## Potassium sulphate (sulphate of potash) fertilizer — Specification

### 1 Scope

This draft African Standard specifies the requirements, sampling and methods of test for field grade potassium sulphate (sulphate of potash) fertilizer.

### 3 Terms and definitions

For the purpose of this standard, the terms and definitions in ISO 8157 apply.

### 4 Requirements

### 4.1 General description

The fertilizer shall be in the form of free-flowing crystalline powder and free from visible contamination.

### 4.2 Physical requirements

When tested in accordance with ISO 8397, the particle size shall be such that not less than 65% of the material shall pass through 1.7 mm IS sieve and be retained on 0.25 mm IS sieve.

### 4.3 Chemical requirements

The fertilizer shall comply with requirements/limits given in Table 1 when tested according to the methods specified therein.

### 4.4 Heavy metal contaminants

The heavy metal contaminants, if present, shall not exceed the limits specified in Table 2.

### 5 Sampling and sample preparation

Sampling and sample preparation shall be carried out in accordance with ISO 14820-1 and ISO 14820-2 respectively.

### 6 Packaging and labelling

### 6.1 Packaging

The fertiliser shall be packed in clean, non-defective and appropriate containers that will protect it integrity during handling, transportation and storage.

NOTE The product may be also supplied in bulk containers.

### 6.2 Labelling

In addition to the labelling requirements of ISO 7409, each container of postassium sulphate fertiliser shall be legibly and indelibly labelled with the following:

- a) name, address and physical location of the manufacturer/packer/importer;
- b) type of the product as potassium sulphate fertilizer;
- c brand name
- d) the minimum potash content, as K<sub>2</sub>O, in percentage by mass;
- d) the net weight of the fertilizer in the package;
- e) handling instructions;
- f) storage instructions;
- g) manufacture and expiry date;
- h) batch/lot number;
- i) Country of origin.
- j) Instructions for use

### 7 Certificate of analysis

A certificate of analysis stating the minimum percentage levels of plant nutrient elements shall accompany every lot or consignment of the fertilizer.

### 8 Material safety

Each container must be accompanied by a Material Safety Data Sheet (MSDS) and Technical Data Sheet (TDS).
